Summer Engineering Institute Program 2024 Checklist

This checklist of action items is required to be completed before the start of SEI. Most of these tasks are mandatory and if not completed by the deadline, may prevent you from participating in SEI.

Office for Students with Disabilities

□ **Step 1:** Complete Mandatory Next steps listed in UC San Diego Enrollment Checklist in the Applicant Portal.

Failure to complete these items by the deadline could result in failure to enroll in Fall 2024. In particular, it is essential for SEI that you submit your transcripts and complete all health checklist items by the deadlines provided within your Enrollment Checklist.

□ **Step 2:** Health Insurance Agreement Form

All undergraduate students are required to have health insurance as a condition of enrollment. Students are automatically charged the SHS/CAPS Summer Access Fee and are enrolled in the UC Student Health Insurance Plan (UCSHIP). Students already enrolled in a comparable health insurance plan may waive UC SHIP coverage by completing a Health Fee Waiver application during the FALL 2024 waiver period.

SHS/CAPS Summer Access

SEI participants who opt out of early start UCSHIP will automatically be charged a \$70 fee and enrolled in the SHS/CAPS Summer Access offering for limited primary care and mental health needs on campus. This is not an insurance plan. SHS/CAPS Summer Access IS NOT health insurance.

Early Start UCSHIP

Since SEI begins prior to the start of the official campus Fall quarter, Early Start UCSHIP coverage is being offered to you for Summer 2024. Students enrolling in the Early Start UCSHIP for Summer 2024 are NOT eligible to waive the UCSHIP during the FALL 2024 waiver period.

Students electing to waive Early Start UCSHIP must submit an online <u>Health Fee Waiver application</u> during the Fall quarter waiver period (May 6th through September 14th) to prevent enrollment in the UCSHIP beginning with Fall 2024.

The cost of Early Start UCSHIP is a one-time supplement fee, prorated based on your program start date. **This fee is \$413.04** with coverage dates of 7/29/2024 through 9/22/2024. Note that this supplemental fee is separate from the quarterly UCSHIP fee.

You must complete a MANDATORY Early Start Insurance Agreement Google Form to opt in to the Early Start UCSHIP coverage. You will receive an email from Student Health Services with more information.
